#### Sub: Registration of stakeholders on Used Oil Extended Producer Responsibility (EPR) Portal for Used Oil - reg.

**Ref:** CPCB letter no. F. No: CO-21/49/2023-WM-II-HO-CPCB-HO-Part(2) dated 02/07/2024 (Copy enclosed)

Sir/Madam,

This has reference to the above referred letter informing about the launch of EPR Portal for used oils with effect from 24/06/2024; wherein it was requested to direct the Producers (including importers of base oil/lubrication oil) to register on the Used oil EPR portal.

It has been observed that the stakeholders namely the Producers and Recyclers are not getting registered on Used Oil EPR portal. The Dashboard information on <u>https://eprusedoil.cpcb.gov.in/</u> indicates that only 77 producers and 33 Recyclers have applied for registration so far. As per Rule 37(2)(i) of HOWM Rules 2023, SPCBs/PCCs are required to ensure proper implementation of the used oil EPR regulation.

In view of above, it is requested that necessary notices/directions may please be issued to the stakeholders of used oil EPR (Producers-including importers of base oil/lubrication oil, Recyclers and Used Oil Importers and Collection Agents) to register on CPCB's EPR Portal within 15 days. It may also inform such entities that failing to register on CPCB's used oil EPR portal may attract imposition of Environmental Compensation against them as per provisions under Rule 39(3) of the Hazardous and Other Wastes (Management and Transboundary Movement) Second Amendment Rules, 2023.

# Sub: Go-Live of EPR Portal for Used Oil Management on CPCB website for Sign-up and Registration -reg.

Sir,

This has reference to the introduction of Extended Producer Responsibility for Used Oil under Hazardous and Other Wastes (Management and Transboundary Movement) Amendment Rules, 2023 notified vide G.S.R 677 (E) dated 18th September, 2023. The said notification has commenced from 1st April, 2024 and the online EPR Portal for Used oil Management to be developed and made functional by the CPCB within six months from the date of commencement of the said Rules.

In this regard, as mandated under the said notification, CPCB has developed the EPR Portal for Used Oil and launched the Sign-up & Producers Registration modules on 24/06/2024. Currently all the entities (Producer/ Recycler/ Importer/ Collection Agent) can Sign-up while the Producers can submit the application for registration.

CPCB has also prepared FAQs addressing the queries raised by various stakeholders in various interactions meets and SoPs for Registration of Producer at EPR Portal; as guidance documents for the stakeholders. The said documents are available on CPCB website and Used oil EPR portal. The URL for the Used oil EPR portal (i.e <u>https://eprusedoil.cpcb.gov.in/</u>) can be accessed through CPCB website (at E- Governance Portals). Further, the remaining modules (Registration of Recycler/Importer/ Collection Agent; EPR Certificate generation and Transaction; Audit; Environment Compensation) are currently under development in phase wise manner.

In view of above, SPCBs/PCCs are requested to direct the Manufactures/Importers of Base oil/lubrication oil/ other products manufactured from base oil to register as "Producer" on the Used oil EPR portal latest by 31/07/2024.
